

1. The Ministry of Basic, Higher, and Technical Education (MBHTE), through the Directorate General for Higher Education, is currently undertaking the regional data consolidation for the Higher Education Management Information System (HEMIS), which aims to ensure that higher education data is updated, completed, and reliable that supports planning, policy development, monitoring, and reporting for the Bangsamoro Higher Education Sector.
2. In this regard, all Higher Education Institutions (HEIs) in BARMM are hereby directed to submit and comply with the following HEMIS data requirements:
 - a. **HEMIS Data for Academic Year (AY) 2025-2026 - 1st Semester** (official and validated enrollment data for the 1st Semester of AY 2025-2026)
 - b. Number of Graduates per Program for AY 2024-2025
3. Please be guided by the submission requirements and the deadline:
 - HEMIS link: <https://hemis-mbhte.morobYTE.com>
 - All submissions must be validated and certified correct by the Institutional Registrar and the Head of the Institution.
 - **Deadline of submission: December 7, 2025.**
4. Timely and accurate submission of HEMIS data is crucial to ensure the integrity of regional higher education data and to support MBHTE's programs, resource allocation, and national reporting obligations. Non-compliance or late submission may be subject to monitoring and follow-up actions.
